Report of the auditor on the financial statements 2020

According to my assignment, I have audited the financial statements of Knightsbridge Investment Fund Limited, which comprise the balance sheet, income statement, statement of net assets attributable to holders of redeemable shares and statement of cash flows ended at 31 December 2020, and a summary of significant accounting policies and other explanatory information.

Responsibility of the Board of Directors

The Board of Directors is responsible for the preparation of the financial statements that give a true fair view in accordance with the prevailing laws, ordinances and general accepted accounting and valuation principles as set out in the by-laws and the offering memorandum. This responsibility includes designing, implementing and maintaining an internal control system relevant to the preparation of financial statements that are free from material misstatement, whether due to fraud or error. The Board of Directors is further responsible for selecting and applying appropriate accounting policies and making accounting estimates that are reasonable in the circumstances.

Auditor's Responsibility

My responsibility is to express an opinion on these financial statements based on my audit. I conducted my audit in accordance with Swiss Auditing Standards. Those standards require that an audit has to be planned and performed to obtain reasonable assurance about whether the financial statements are free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the entity's preparation of financial statements that give a true and fair view in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control.
